RESOLUTION NO. 13-2025

A RESOLUTION AUTHORIZING THE FISCAL OFFICER TO AMEND THE CERTIFICATE OF ESTIMATED RESOURCES FOR THE YEAR 2025 AND DECLARING AN EMERGENCY

WHEREAS, Council approved certain items within the provisions of said budget via Resolution No. 66-2024, No. 10-2025, and No. 12-2025; and

WHEREAS, the Fiscal Officer submitted a revised Certificate of the Total Amount from all Sources Available for Expenditures and Balances to the Lake County Auditor on January 17, 2025; and

WHEREAS, the Lake County Budget Commission provided an Official Certificate of Estimated Resources on February 3, 2025 and a revised Certificate on February 18, 2025; and

WHEREAS, the Village of Perry Council now requests an amended Certificate of Estimated Resources based on the finalized balances of Fiscal Year 2024 and additional sources of revenue identified for the Fiscal Year 2025.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF PERRY, COUNTY OF LAKE, AND STATE OF OHIO, AS FOLLOWS:

Section 1. That, effective the 27th day of February, 2025, the Fiscal Officer of the Village is hereby authorized, directed and approved to take all necessary steps to amend the Certificate of Estimated Resources for the year 2025, attached as Exhibit A (a one page document) and included herein by reference.

Section 2. That all formal actions of this Council concerning the passage of this Resolution were adopted in an open meeting, and all deliberations of this Council, or any of its Committees, which resulted in such formal actions, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 3. That this Resolution is hereby declared to be and is passed as an emergency measure, the emergency being the need to continually provide for the fair and prudent administration of Village affairs. Said resolution is necessary for the immediate preservation of the public, peace, health, safety and welfare of the inhabitants of the Village of Perry.
