Police activity for January 2025

During the month of January there were 509 calls for service, which resulted in 2 incident reports to include the following;

- Disorderly
- Suspicious Circumstance

Traffic Enforcement

- 32 traffic details were conducted
- 14 warnings were issued
- 7 citations were issued
- 4 parking violation
- 2 Traffic crashes

Equipment-

- Quarterly sub-grant report for the body worn cameras was returned from OCJS requiring budget modifications to address the vendor invoicing description differences in comparison to original quotes/approved budgets. Currently in process of making adjustments and will resubmit.
- Radios and equipment has started to arrive. We will be coordinating install/implementation in the near future
- Fire extinguishers- Need a determination if we want to stay with a service provider or purchase on our own.
 - Annual fire extinguisher inspection was completed in the fall of 2024 by Silco who bought out the previous company, Five Star. It was learned during the inspection that Five Star should not have been inspecting and tagging several of the existing fire extinguishers due to some of them being obsolete and cannot be inspected, repaired or rebuilt. The inspection and service cost for the extinguishers that could be inspected and have maintenance performed on is \$844.35. To replace the fire extinguishers that were obsolete and to add fire extinguishers to the cruisers that did not have them is \$2496. These amounts include the road department and village hall.
 - Price research on Amazon revealed a significant upfront savings. However, there are several factors to consider for purchasing online in comparison to Silco. In order for Silco to conduct the annual inspection in the future the following would have to occur and additional costs applied
 - The fire extinguishers purchased must meet local and NFPA standards
 - Tagging the unit would be \$9.75 per unit verse the current rate of \$5.75
 - \$75 trip charge to conduct the inspection
 - Silco would not warranty any products purchased outside of them. Their extinguishers come with a 6 year warranty
 - Fire extinguishers purchased through Silco have free disposals. Extinguishers purchased outside of Silco will cost \$20-\$40 to dispose of the old fire extinguishers.
 - Waiting on additional quote from Gene Ptacek & Son Fire Equipment Co.

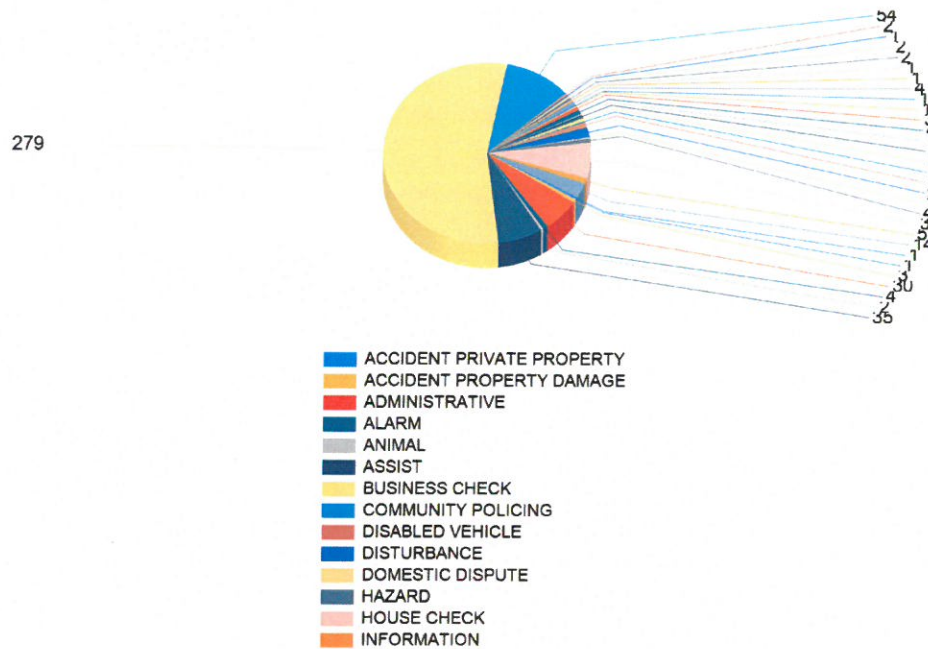
