Police activity for February 2025

During the month of February there were 460 calls for service, which resulted in 4 incident reports to include the following;

- Suspicious Circumstance- still under investigation
- Online Scam- closed no further investigation
- Bomb Threat- juvenile arrested
- Sex Offense- still under investigation

Traffic Enforcement

- 28 traffic details were conducted
- 21 warnings were issued
- 7 citations were issued
- 8 parking violation

Equipment-

- The body worn camera grant's quarterly sub-grant required budget modifications. The modification were made, submitted and approved. Waiting on the reimbursement process.
- Radios and equipment arrived and was turned over to the vendor/installer for programming by Lake County IT. The vendor will advise when ready to start the install process.
- Fire extinguishers- Need a determination if we want to stay with a service provider or purchase on our own.
 - Annual fire extinguisher inspection was completed by Silco who bought out the previous company, Five Star in Aug/ Sept. 2024 timeframe. At that time it was learned during the inspection that Five Star should not have been inspecting and tagging several of the existing fire extinguishers due to the extinguisher itself is obsolete and cannot be inspected, repaired or rebuilt.
 - The inspection and service cost of the extinguishers that could be inspected and maintenance performed on is \$844.35. To replace the fire extinguishers that were obsolete and to add fire extinguishers to the cruisers that did not have them is \$2213. These amounts include fire extinguishers for the road department and village hall.
 - Price research on Amazon revealed a significant upfront savings. However, there are several factors to consider for purchasing online in comparison to Silco. In order for Silco to conduct the annual inspection in the future the following would have to occur and additional costs applied
 - The fire extinguishers purchased must meet local and NFPA standards
 - Tagging the unit would be \$9.75 per unit verse the current rate of \$5.75
 - \$75 trip charge to conduct the inspection
 - Silco would not warranty any products purchased outside of them. Their extinguishers come with a 6 year warranty
 - Fire extinguishers purchased through Silco have free disposals. Extinguishers purchased outside of Silco will cost \$20-\$40 to dispose of the old fire extinguishers.
 - Gene Ptacek & Son Fire Equipment Co. quote received. Both Silco and GPS quotes attached.

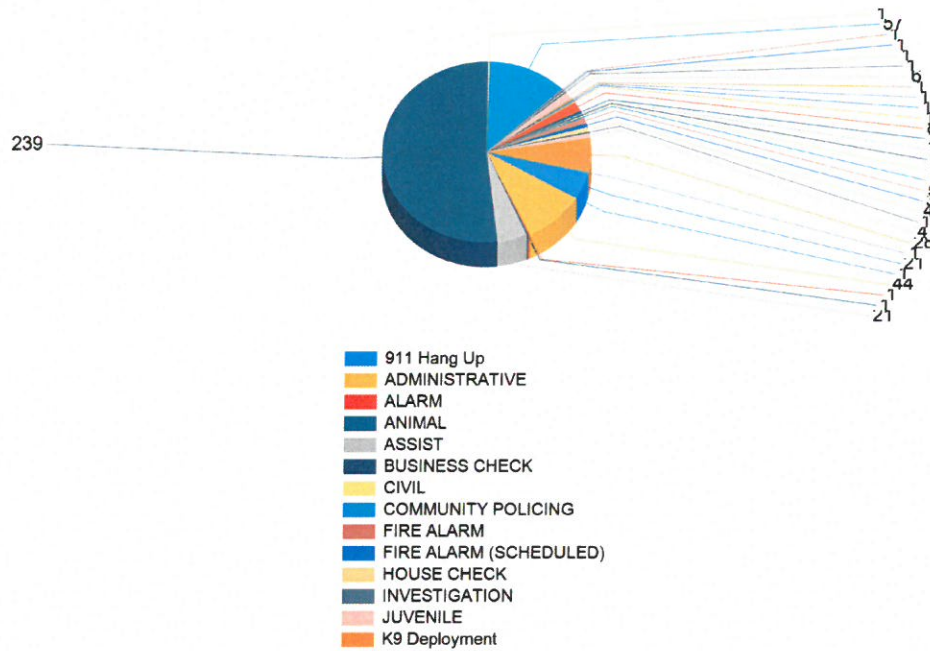
