

RESOLUTION NO. 28-2025

A RESOLUTION AMENDING RESOLUTION NO. 66-2024 AND APPROVING THE PERMANENT APPROPRIATIONS FUNDS FOR THE VILLAGE OF PERRY, OHIO FOR THE YEAR 2025 AND DECLARING AN EMERGENCY.

WHEREAS, Council has previously approved the 2025 Village of Perry Permanent Appropriation on Resolution No. 66-2024 and amendments via Resolution No. 10-2025, No.12-2025, and No. 22-2025; and

WHEREAS, Council approved certain items within the provisions of said budget; and

WHEREAS, Council now wishes to make additional amendments to the Permanent Appropriation for Fiscal Year 2025 as detailed in Exhibit A, a one-page document attached and made a part hereof; and

WHEREAS, Council finds it is to be in the best interests of the residents of the Village that such Permanent Appropriations be amended, authorized and approved.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF PERRY, COUNTY OF LAKE, AND STATE OF OHIO, AS FOLLOWS:

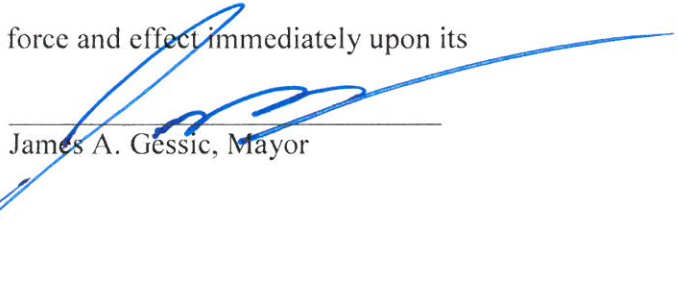
Section 1. That, effective the 8th day of May, 2025 the Fiscal Officer of the Village of Perry is hereby authorized, directed and approved to take all necessary steps to amend the permanent appropriations in the budget for the tax year 2025

Section 2. That all formal actions of this Council concerning the passage of this Resolution were adopted in a open meeting, and all deliberations of this Council, or any of its Committees, which resulted in such formal actions, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 3. That this Resolution is hereby declared to be and is passed as an emergency measure, the emergency being the need to continually provide for the fair and prudent administration of Village affairs. Said resolution is necessary for the immediate preservation of the public, peace, health, safety and welfare of the inhabitants of the Village of Perry.

WHEREAS, this Resolution shall be in full force and effect immediately upon its passage.

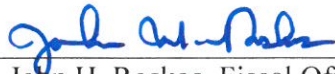

Exhibit A

Increase 1000-745-342-0000 "Auditing Services" from \$7,000.00 to \$10,000.00

- Additional funds required due to change from agreed upon procedures audit to a regular audit, as required by the Auditor of State.

Increase 1000-230-600-0000 "Other Assistance to Needy- Other" from \$0 to \$1,300

- This is to pay for costs for an indigent burial as required under the provisions of ORC 9.15; the Village will submit costs for reimbursement to the State of Ohio Board of Embalmers and Funeral Directors Indigent Burial and Cremation Support Program. We can receive reimbursement up to \$1,000, so long as there are enough funds available in the program.
