

**RESOLUTION NO. 63-2025**

**A RESOLUTION AMENDING RESOLUTION NO. 66-2024 AND APPROVING THE PERMANENT APPROPRIATIONS FUNDS FOR THE VILLAGE OF PERRY, OHIO FOR THE YEAR 2025 AND DECLARING AN EMERGENCY.**

**WHEREAS**, Council has previously approved the 2025 Village of Perry Permanent Appropriation on Resolution No. 66-2024 and amendments via Resolution No. 10-2025, No.12-2025, No. 22-2025, No. 28-2025, No. 36-2025., No. 41-2025; and No. 52-2025

**WHEREAS**, Council approved certain items within the provisions of said budget; and

**WHEREAS**, Council now wishes to make additional amendments to the Permanent Appropriation for Fiscal Year 2025 as detailed in Exhibit A, a twelve-page document attached and made a part hereof; and

**WHEREAS**, Council finds it is to be in the best interests of the residents of the Village that such Permanent Appropriations be amended, authorized and approved.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF PERRY, COUNTY OF LAKE, AND STATE OF OHIO, AS FOLLOWS:**


Section 1. That the Fiscal Officer of the Village of Perry is hereby authorized, directed and approved to take all necessary steps to amend the permanent appropriations in the budget for the fiscal year 2025.


Section 2. That all formal actions of this Council concerning the passage of this Resolution were adopted in an open meeting, and all deliberations of this Council, or any of its Committees, which resulted in such formal actions, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 3. That this Resolution is hereby declared to be and is passed as an emergency measure, the emergency being the need to continually provide for the fair and prudent administration of Village affairs. Said resolution is necessary for the immediate preservation of the public, peace, health, safety and welfare of the inhabitants of the Village of Perry.

**WHEREAS**, this Resolution shall be in full force and effect immediately upon its passage.

Increase 1000-110-100-1030 Personal Services {Police – Hourly Part/Time} from \$70,000.00 to \$73,000.00

Increase 1000-110-211-1030 Ohio Public Employees Retirement System {Police- Hourly Part/Time} from \$9,800.00 to \$10,220.00

Increase 1000-110-213-1030 Medicare {Police – Hourly Part/Time} from \$1,015.00 to \$1,065.00

Increase 1000-310-311-0000 Electricity from \$1,500.00 to \$1,700.00

Increase 1000-620-100-6220 Personal Services {Road Part/Time} from \$78,000.00 to \$81,000.00

Increase 1000-620-211-6220 Ohio Public Employees Retirement System {Road Part/Time} from \$10,920.00 to \$11,420.00

Increase 1000-620-213-6220 Medicare {Road Part/Time} from \$1,131.00 to \$1,175.00

Increase 2903-110-300-0000 Contractual Services from \$700.00 to \$1,000.00 (additional funds for Veterinarian Services for K9)

Additional increases or decreases not listed above not to exceed \$5,000, between any 1000 General Fund Police Department “Personnel Expense and Benefit” and Road Department Line Items as necessary for the final payroll of Fiscal Year 2025.
